This represents additional costs that importers pay when bringing goods into the United States from Botswana. 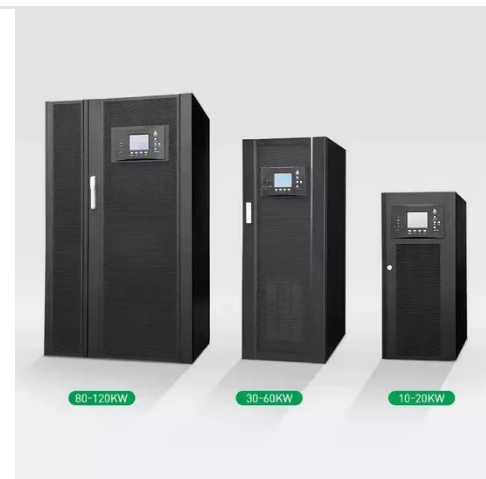

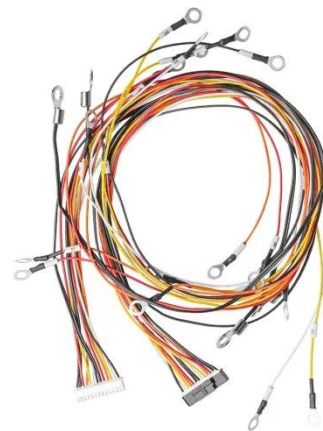
