

Are re-imported goods subject to customs duty in Nepal?

Goods re-imported after being manufactured or finished in Nepal are subject to customs duty similar to foreign imports, with exceptions for certain circumstances such as undelivered parcels or quality issues. Importers may opt for government ownership of imported goods, waiving duty.

What is customs law in Nepal?

1. Introduction to Customs Law in Nepal The Customs Act 2064 governs the import and export of goods, imposing customs duty on nearly all items except those explicitly exempted.

How to import goods into Nepal?

Import into Nepal requires the payment of a number of duties, taxes, and charges imposed by customs officials to ensure that correct regulations are followed for goods to be brought into or taken out of the country. These are based on the type, value, and origin of the goods. Below are the main fees you should know about: 1. Customs Duty.

How do exporters & importers get customs clearance in Nepal?

All exporters and importers must obtain the export, import code (EXIM code) which is issued by the Department of Customs of Nepal. Import customs clearance methodology to deliver imported goods to importer is same in almost all ports worldwide. Detailed information about import customs process

Nepal prohibited import items include weapons, narcotics, certain chemicals, and products threatening public health or environmental security.


