Are solar and related components exempt from customs tariff?

To have enough energy for domestic use, solar and related components are exempt from custom tariff, according to the Ministry. In the Customs tariff exemption list are as follows.

What are photovoltaics used for in Myanmar?

In rural areas, photovoltaics are used for charging batteries and pumping water. 70% of the Myanmar population of live in rural areas. Myanmar's opened its first solar power plant in Minbu, Magway Division, in November 2018. It can produce as much as 170MW of electricity.

How do I view the Myanmar customs tariff?

To view the Myanmar Customs Tariff, or if you are interested in a particular commodity use the commodity search function on the home page. Imports from ASEAN States enter at preferential tariff rates under ASEAN Trade in Goods Agreement-ATIGA.

Does Myanmar have a 40% tariff rate?

When importing goods from Myanmar (Burma) subject to the 40% tariff rate, businesses must ensure proper compliance with customs regulations.

How to import from Myanmar (Burma)?



Importing from Myanmar (Burma) requires proper customs declarations, country of origin documentation, HS code classifications, and payment of the 40% tariff rate along with any other applicable duties and taxes.
