

# Tariffs on Algerian PV module exports





#### **Overview**

How much is a feed-in tariff in Algeria?

The preferential feed-in tariffs will be guaranteed for the 20-year term of the PPA. Base tariffs will range from 12.75 Algerian dinars per kilowatt hour (DZD/kWh) to 15.94 DZD/kWh (EUR 0.12 per kilowatt hour (EUR/kWh) to 0.15 EUR/kWh based on prevailing exchange rates) for solar photovoltaic projects.

What is the tariff structure in Algeria?

The tariff structure in Algeria plays a pivotal role in the importation of goods, impacting the overall cost of doing business for traders. Tariffs can generally be categorized into two major types: ad valorem tariffs and specific tariffs.

How much solar power does Algeria have?

By the end of 2023, Algeria had 437 MW of solar generation capacity, according to the national Commission for Renewable Energies and Energy Efficiency (CEREFE). The country has an average of 3,000 hours of sunshine per year and global horizontal irradiation of almost 1,700 kWh/m²/year in the north and 2,263 kWh/m²/year in the south.

Can Algeria replace its gas and oil exports?

To gradually replace its gas and oil exports, Algeria aims to position itself on the international energy scene as a supplier of blue hydrogen (produced by steam reforming gas equipped with carbon capture technology) and green hydrogen (produced via electrolysis powered by renewables).


